Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### Services of the Funeral Home and Staff

Basic Services of Funeral Director and Staff and Overhead..... \$3095

Our services include conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic **services and overhead** will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming ..... \$825

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Disinfecting, dressing, casketing and/or cosmetizing..... \$265

Bathing, Disinfecting, and handling of the deceased (unembalmed)..... \$345

Special Care for Autopsied Cases..... \$205

Our charge includes basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory.

Direct Cremation.....\$2700 to \$3410

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations and cremation.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard and fiberboard containers.

- B. Direct cremation with First Step wood grain fiberboard container ..... \$3410
- C. Direct cremation with Danson Teakwood fiberboard container..... \$3220
- D. Direct cremation with Basic Cremation Container (cardboard)..... \$2910

Immediate Burial.....\$2300 to \$4080

Our charge for an immediate burial (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

- A. Immediate burial with casket provided by the purchaser ..... \$2300
- B. Immediate burial with cloth covered cardboard casket (Fayette) ..... \$4080
