Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations, cremation process, Alternative Container and Temporary Cardboard Urn.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a corrugated cardboard container.

## **New Offerings:**

## Aquamation (Alkaline Hydrolysis) and Terramation (Natural Organic Reduction)

This charge includes the basic overhead and necessary fees to carry out the local transfer of the deceased to the funeral home, temporary shelter of remains, filing the death certificate and obtaining a disposition permit. It includes consultation with the family, hydrolysis or terramation charges and the return of the processed remains to the funeral home. An outer enclosure is not required. An urn selection will be requested for final disposition or memorialization purposes.
