These prices are effective November 15, 2023 but are subject to change without notice

You will be charged for only the items you select. Please note that there may be extra charges for items selected by you that are not in the price list such as cemetery fee, flowers and newspaper notices or for items and services by funeral directors or direct disposers if funeral services are not purchased from the funeral home named above.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

ITEMIZED SERVICES

Basic Services of Funeral Director and Staff and Overhead.....\$160.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation. This fee includes, but is not limited to, availability of staff 24-hours a day, staff and facilities to respond to initial request for services, consultation with responsible party to determine services desired, coordinating service plans with a cemetery, crematory and/or other parties involved in final disposition of the deceased, and filing local death certificate. Also included in this fee are overhead expense related to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs and equipment and inventory expenses.

- Dressing and Casketing of Remains.....\$160.00
- Delivery of Cremated Remains to Local Cemetery or Residence (45 mile radius of Vegas Valley Cremation office).....\$160.00
- Packaging and Shipping Cremated Remains via Priority Express Mail (within continental US).....\$160.00
- Priority Express Mail of Documents (within continental US).....\$40.00
- Mailing of Keepsake Urn via Priority Express Mail (within continental US).....\$80.00
- Transportation for Secondary Removal from Medical Examiner.....\$160.00

Direct Cremation.....\$895.00 - \$950.00

Our charges for direct cremation (without ceremony) includes: the basic services of funeral director and staff, transportation within our Service Area, use of licensed climate-controlled holding facility up to 7 days and cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a cardboard container.
