Basic Services of Funeral Director and Staff

\$2,305.00

Our fee for the basic services of Funeral Director/Staff includes personnel available 24 hours a day, 365 days a year to respond to the initial call, arrangement conference, preparation, securing and filing of the death certificate and disposition permit, securing signatures of doctor, medical examiner and county registrar, planning the service, coordination of service plans with crematory, cemetery, clergy, florist, and others as required for the final disposition. This fee for our basic services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations and direct burials.

Embalming

\$720.00

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure.

Except in certain special cases, Embalming is not required by law. Embalming may be necessary, however if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Memory of a Lifetime Video Presentation

Private Family Viewing

\$305.00

An appointment is required for a private family viewing, with 24-hour advance notice to the funeral home and is strictly limited to fifteen minutes by five individuals. Additional private family viewings, following the initial viewing, will result in a \$305 fee per viewing. There are NO exceptions with regards to the amount of people and the charges. We do not offer viewing or services without embalming which is why we limit the private family viewings by time and amount of people. The private family viewings are only performed Monday-Thursday from 10am to 2pm. Identification viewings outside of that time are not performed without charges. All private family viewings are held at Mohave Memorial Funeral Home in Kingman, AZ.

Local Transfer of Decedent to Funeral Home

\$560.00

Local transfer is a removal within a 25-mile radius of the funeral home. Additional charges will apply beyond the 25-mile radius at an additional \$6.00 a mile.

Additional Preparation of the Body

\$310.00

This charge is for any of the following additional preparation: dressing, casketing, cosmetology, hairdresser, bathing/sanitation and handling of an un-embalmed deceased.

Reconstructive Restoration \$310.00
This charge is per hour for any restoration that may need to be performed.

Care and Housing (Refrigeration) \$130.00
This charge is per day from the original date that the deceased arrives at our care center.

Use of Facilities and Staff \$565.00
This charge is per hour (1 hour minimum) including but not limited to the use of staff or facilities for viewing/visitation, funeral service, memorial service, celebration of life, graveside service, reception, or ceremonial/medical use. These charges are for the use Monday through Friday between the hours of 10AM to 2PM. Additional charges will apply for after hours and holidays use of facilities and staff. The additional fee for after-hours is a \$500 one-time fee (in addition to the per hour charge)

After Hours Fee \$500.00
An additional After-Hours Fee applies in addition to any services. After Hours are outside of the use of facilities time frame of Monday through Friday 10AM to 2PM. This includes any weekend or holiday services.

International Shipping Document Preparation \$750.00 to \$2,000
This charge is the process in which we secure the documentation needed to send your loved one back home. In order to allow your loved one to be shipped outside the United States we must secure documents from the following entities, including but not limited to, the embassy of the receiving country, local coroner's approval, and local Health Department Approval.

Direct Burial \$2,200.00 to \$11,645.00
Our charge for direct burial, without viewing or ceremony, includes local transfer of decedent to funeral home, reduced basic services of funeral director and staff, refrigeration (5 days), transportation to the local cemetery at the convenience of the funeral home and cemetery. No additional preparation of the body including but not limited to embalming, dressing, casketing and cosmetology.

Immediate burial with casket or container provided by purchaser \$2,200.00
Immediate burial with minimum cloth-covered Flat Top Casket (\$1045) \$3,245.00
Immediate burial with Sentry 20 gauge steel (NG) casket (\$2,620) \$4,820.00

Direct Cremation \$1,365.00 to \$10,810.00
Our charge for direct cremation, without viewing or ceremony, includes local transfer of decedent to funeral home, reduced basic services of funeral director and staff, refrigeration (5 days), transportation to crematory, crematory fee, plastic urn and sales tax. A crematory fee of \$360 is included in the direct cremation prices. If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide are is a cardboard cremation box.
