General Price List – Effective October 12, 2023

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for basic services of the funeral director and staff and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

1. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$3,950.00

This includes, but is not limited to, consultation with family; arrangement of funeral; preparation and filing of necessary documents, permits, and certificates, coordination with those providing other portions of the arrangements, e.g. the cemetery, crematory, etc. This also includes our charge for overhead expenses such as insurance, maintenance, utility, and normal administrative costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. Portions of this fee are included in charges for direct cremations, immediate burials, and forwarding and receiving of remains.

2. EMBALMING \$930.00

Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you choose certain funeral arrangements such as a funeral with a viewing. This firm offers on premises refrigeration for families preferring no embalming.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$4,500.00

This charge includes removal of the remains within 25 miles, basic services of funeral director and staff, embalming or refrigeration, shipping container or approved airline tray, necessary authorization with receiving funeral home and transportation to Tampa International Airport. This charge does not include visitation, viewing, rites or ceremonies, prior to forwarding of the body (Inner Sealer requires or unembalmed shipments).

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$3,740.00

This charge includes temporary shelter of remains up to 48 hours, proportionate share of basic services of funeral director and staff, and transportation from Tampa International Airport to local cemetery or crematory within 25 miles. It does not include visitation, rites, ceremonies, or merchandise.

IMMEDIATE BURIAL \$5,880.00 down to \$4,680.00

Our charge for immediate burial includes removal from place of passing within 25 miles, refrigeration up to 48 hours, local transportation to cemetery, proportionate share of basic services of funeral director and staff and necessary authorizations. It does not include use of facilities and staff for visitation, rites or ceremonies, public or private, prior to burial.

Our charge for a direct cremation includes removal of the remains from place of passing within 25 miles, refrigeration up to seven days, basic crematory fee, necessary authorizations and proportionate share of basic services of funeral director and staff. This charge does not include the use of any facilities and staff for visitation or ceremonies, public or private. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body prior to cremation and can be made of materials like fiberboard or composition materials (with or without coverings). The containers we provide are fiberboard or composition materials.
