The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

## DIRECT CREMATION SERVICES

Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations and cremation.

*If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.*

Direct cremation is the disposition of the body by cremation, without embalming, formal viewing or ceremony. Our charges include:

A. Direct Cremation with casket provided by purchaser \$745

B. Direct Cremation with cardboard alternative container \$795

Witness cremation no viewing (Time scheduled by the crematory) \$ 210

Witness cremation with viewing at crematory  
(Time scheduled by the crematory, 10 people 30 minutes) \$ 310

Witness cremation with autopsy repair  
(Time scheduled by the crematory) \$ 395

Identification Viewing – 10 people 45 minutes \$ 275

Minimum Preparation for visual identification \$ 195

Immediate Burial \$ 885 to \$3595

*This charge includes transfer of remains to funeral home, refrigeration, basic services of funeral director and staff, facilities and transportation to cemetery (in service van at the convenience of the funeral home). This charge does not include embalming, merchandise, viewing or ceremony.*

A. Immediate burial with casket provided by the purchaser \$ 885

## ITEMIZED SELECTIONS

Basic Services of Funeral Director and Staff \$ 395

Our services include conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

(This fee is already included in our charges for direct cremations.)

Transfer of remains to our facility within 45-mile radius \$195  
(beyond this radius we charge \$5.50 per mile)
