You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff** **\$ 2,225.00**

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for services; arrangements conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorization and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following, coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, and utilities expenses, secretarial and administrative cost, equipment and inventory cost.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains).

**Embalming** **\$ 650.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Our charge for this service includes removal of remains (Brevard County), limited services of staff, embalming, required airline container and local transportation to airport. This charge does not include visitation, rites, or ceremonies prior to forwarding of body.

**Receiving of Remains From Another Funeral Home****\$ 2,355.00**

Our charge for this service includes transfer from airport to Funeral Home, transportation of remains to cemetery, Utility vehicle and limited services of staff. This charge does not include visitation, rites or ceremonies.

**Immediate Burials****From \$ 3,750.00 to \$ 18,080.00**

Our charge for this service includes removal of remains (Brevard County), Refrigeration, Limited basic services of the funeral director and staff, Sanitary Care of Remains, Dressing and Casketing of remains and transfer to cemetery.

Our charge for this service includes basic service of funeral director and staff, transfer of remains to funeral home within 25-mile radius, embalming per the Anatomical Board requirements and transportation to the Anatomical Board of Florida which is located in Orlando. This charge does not include other preparation of the body, dressing, casketing, cosmetic application, use of facilities, equipment or staff for viewing, rites, ceremonies or gatherings, merchandise or cash advances.

**Direct Cremation****From \$2,090.00 to \$ 2,155.00**Our charge for this service, without any attendant rites or ceremonies, includes the local transfer of the deceased into our care (Brevard County), limited basic services of the funeral director and staff, obtaining necessary permits and authorizations, preparation and/or placement of newspaper notices, filing Social Security and Veteran's forms, refrigeration until cremation, care of the deceased (limited to feature setting) and use of the facilities for private identification (limited to a next of kin or personal representative), use of private crematory and Standard Cremation Fee. State and local law does not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). *The containers we provide are: Corrugated Cardboard and Medium Density Fiberboard (MDF).***Our charge for Direct Cremation includes the Standard Cremation Fee.**
