These prices are effective as of May 9, 2024

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. All services and merchandise shall be governed by the Conditions of Service, Cremation Notice and Funeral Goods and Services Agreement.

**PROFESSIONAL SERVICES**

**Basic Services of Funeral Director and Staff..... \$960.00**

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service, arrangement conference with family and responsible parties, arrangement of funeral, consulting with family and clergy, preparing and filing of necessary authorizations and permits, coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

**This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)**

**Embalming ..... \$725.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**OTHER PREPARATION OF THE BODY**

**Refrigeration..... \$185.00**

It is our policy to refrigerate immediately upon receiving remains. This fee includes the initial four days of refrigeration, after which this funeral home reserves the right to charge a daily refrigeration fee of \$80.00 per day.

<b>Private Identification Viewing</b> .....	<b>\$205.00</b>
Includes Minimal Preparation of the body, setting features, viewing of the body on a cot or table. Does not include bathing, embalming, dressing, cosmetology, cremation container, alternative container, casket or autopsy repair. One or more of these services may be required for a private viewing. Viewing time is limited to 5 immediate family members, for a period of time not exceeding 15 minutes.

<b>FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME</b> .....	<b>\$1130.00</b>
Our charge includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; embalming or other preparation of remains and transportation to Phoenix Sky Harbor International Airport. <b>This charge does not include shipping container, autopsy/donor restoration, or transportation charges such as airfare or ground transportation.</b>	

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME ..... \$1030.00**  
Our charge includes basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory. **This Charge does not include visitation, funeral ceremony or graveside service.**

**DIRECT CREMATION ..... From \$1,256.00 to \$1,941.00**  
Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains (within a 30 miles radius); transportation to crematory and necessary authorizations. The crematory fee and Medical Examiner's cremation authorization fee are included in these charges. These charges do not include Private Identification Viewing, Memorial Service and or Chapel Service. **All cremations are governed by the Conditions of Service, Cremation Notice and Funeral Goods and Service agreement.**

**B. Direct cremation with Minimum Cardboard Cremation Container .....\$1361.00**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials (with or without an outside covering). We provide are cardboard, fiberboard, or unfinished wood containers.

**C. Direct cremation with a Minimum Casket (Galaxy) .....\$1941.00**

**Cremation Fee (up to 249 lbs) .....\$260.00**

**Persons weighing 250 pounds or more will require a more supportive cremation container, such as the Hard Bottom Cremation Tray. Additionally, the following additional cremation fee will change depending on weight:**

**IMMEDIATE BURIAL .....From \$1,605.00 to \$10,625.00**

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery (within a 30-mile radius). These charges do not include embalming, dressing, public viewing, chapel or graveside service.
